Keg Registration	D. Salafsky introduced Allison Jacobs, Campus Health intern at UA. A. Jacobs conducted a literature review on Keg registration and presented the findings to the TFRUD. A discussion followed the presentation and questions were raised on the jurisdiction (City, County, State) in which efforts for Keg Registration laws could be enacted. D. Salafsky also inquired how other states had funded their Keg registration processes. A. Bass announced that the CPC Steering Committee has approved the inclusion of a Keg Registration effort into the SPF SIG project. M. Pryor agreed that the Keg Registration Laws would help support the Social Host Ordinance enforcement efforts. The group agreed and decided to continue investigation the effort. D. Salafsky suggested getting local UA area retailers involved and also to inquire on their position on this. More information is needed; however the plan is to move forward on the process.	C. Amethyst Initiative	R. Sowards updated the group on the recent nationwide action among some university presidents to propose lowering the drinking age to 18. After some discussion the TFRUD agreed that the group would welcome a debate on the issue as the research clearly shows the benefits to keeping the drinking age at 21. Y. Herrera proposed a motion for the TFRUD to officially "oppose the Amethyst Initiative". L Oien seconded the motion. The group approved the motion all in favor. D. Salafsky agreed to get this item on the Commission agenda.	D. Salafsky to get the Amethyst item on the Commission agenda.
837-Safe TPD UAD Tip Line	M. Pryor informed the group that the TPD has officially activated the underage drinking tip line. The line has a recorded message which will take reports of UAD events, incidents involving over serving, intoxicated driving and other alcohol related calls. The line will be checked at least 2 times a week. TPD is working with the Community Prevention Coalition to develop a protocol for involving community support, party dispersal efforts and promotion of the line. The TFRUD will be invited to attend the next CPC Media Marketing Outreach Support Subcommittee meeting to begin media promotion in Tucson. M. Pryor will present at the MMOSS mtg. M. Pryor noted that the Tip Line is another way to increase the enforcement of the Social Host law passed July 2007 as a result of the TFRUD work.
